Overview of the EIS scoping meeting




- DOE is preparing an environmental impact statement (EIS) to consider **potential impacts to the human environment** from establishing energy conservation standards for manufactured housing
- We are in the **public scoping phase** of the EIS planning process under the National Environmental Policy Act (NEPA)
- The purpose of this meeting is to provide tribal governments, regulatory agencies, and the public an **opportunity to comment** on the **scope of the EIS** and to identify issues to be addressed

Please note: We are *not* taking comments on the proposed rule for energy conservation standards during this EIS scoping. Comments on the proposed rule will be accepted by DOE *after it is published* in the Federal Register. At that time, DOE will hold a public webinar, and there will be a 60-day public comment period for the proposed rule.


How to comment during this meeting

- After the presentation has concluded, we will invite oral comments on the scope of the EIS.

Purpose and need for the proposed action



- DOE's **purpose and need** for the proposed action is to establish energy conservation standards for manufactured housing, as required by the Energy Independence and Security Act of 2007 (EISA)
- DOE is Congressionally directed to establish standards based on the latest version of the International Energy Conservation Code (IECC), subject to cost-effectiveness considerations
- Further, the proposed action would help achieve the national goals of:
 - (a) **saving energy**
 - (b) **reducing energy costs** for manufactured homeowners
 - (c) **reducing greenhouse gases** and other outdoor pollutants



EIS timeline and opportunities for public comment



DOE's proposed action and alternatives

Proposal	Tiers	Price Threshold	Efficiency Level
Proposed action	None	None	Based on 2021 IECC
Action alternative	Tier 1	At or below a retail price threshold*	More limited improvements, up to a maximum incremental price increase**
	Tier 2	Above price threshold*	Based on 2021 IECC
No-action alternative	None	None	None

As part of considering affordability in developing the proposed rule, DOE is currently considering:

** A retail price threshold between \$50,000 – \$100,000*

*** A maximum incremental price increase between \$500 – \$1,000*

IECC = International Energy Conservation Code

Preliminary EIS scope



- The EIS for proposed energy conservation standards for manufactured housing will assess **potential impacts** of the **proposed action** and **alternatives** on the human environment, in order to:
 - Discuss **significant** environmental impacts
 - Evaluate **reasonable alternatives** that **avoid or minimize adverse impacts** or **enhance the quality** of the environment

DOE invites your comments on the scope of the EIS, which might include:


- ✓ Specific resources to be evaluated that have the potential to **significantly impact** the human environment
- ✓ Reasonable **alternatives** to the proposed action for energy conservation standards
- ✓ Measures to **mitigate impacts**, which could be considered in the EIS

Reminder: We are *not* taking comments on the *proposed rule* as part of public scoping for the EIS. Comments on the proposed rule will be accepted *after* it is published in the Federal Register (on or after Aug 16, 2021). At that time, DOE will hold a public webinar and there will be a 60-day public comment period for the proposed rule.


